## **DUAL representation**

If the Borrower wishes to select one of the pre-approved solicitors above, the Borrower will be required to:

## **SEPARATE** representation

If the borrower wishes to choose another law firm to act in the transaction on a separate representation basis (OR if a dual representation is not applicable), the Borrower will be required to instruct a firm to act on his/her behalf that meets our criteria.

Details of a chosen law firm, name of the appointed solicitor and his/her contact details will be required.

MT Finance will then instruct a firm to act on our behalf.

Please note that the Borrower will be responsible for all, i.e. both sets of legal fees. Please note that if the matter does not proceed, any legal costs incurred will be the responsibility of the Borrower.
